



Residential Snow Removal Continues in North End (Zone 1)

As Town of Ponoka crews continue working to remove snow from roadways throughout the community, snow removal operations are underway in the North End (Zone 1) today, January 22 along the following roadways:

- 58 Avenue from 50 Street to Highway 2A;
- 59 Avenue from 51 Street to Highway 2A;
- 60 Avenue from 50 Street to Highway 2A;
- 50A Street from 60 Avenue to 62 Avenue; and
- 56 Avenue from 50 Street to 53 Street.

Beginning Friday, January 23, snow removal operations will begin along the following roadways:

- 61 Avenue from Highway 2A into 61 Avenue Close;
- 62 Avenue from 51 Street to 50A Street;
- 63 Avenue from 51 Street east to the end of the road;
- 50A Street Close; and
- 63 Avenue Close.

Snow removal on roadways in residential zones is expected to continue over the coming weeks. Once the North End (Zone 1) is completed, crews will move into Riverside (Zone 4) next. More details on which streets are scheduled to receive snow removal will be provided at that time.

Snow and ice control crews are also:

- Sanding roadways throughout the community as needed; and
- Sanding and clearing snow on sidewalks adjacent to Town-owned properties and on walking trails, as well as clearing snow from park furniture (benches, picnic tables, etc.) in Town parks and throughout the trail system.

'No Parking' Signs

Please watch for 'No Parking' signs and move parked vehicles from roads when the signs are posted.

Removing your vehicle from the roadway when 'No Parking' signs are posted in advance of snow removal operations is a requirement under the Town's Traffic Bylaw and can result in fines and towing of the vehicle at the owner's expense if needed.

Removing your vehicle from the road also helps crews conduct snow and ice control operations safely and more efficiently.

Community Advisory Signs

Community advisory signs are also posted in residential neighbourhoods 48 hours in advance of snow removal operations to give residents notice of when snow removal is scheduled to occur.

Please note that changing weather conditions and new snowfall events can require crews to direct their attention back to priority routes and delay planned snow removal operations. As a result, crews may not complete the entire zone and will return at a later date.

How to Report an Icy or Snow-Covered Intersection, Roadway, Back Alley or Sidewalk

To report an icy or snow-covered intersection, roadway, back alley, sidewalk or walking trail that may need attention, please submit an online service request by visiting the Town of Ponoka website at Ponoka.ca/p/online-service-request. Or you can phone the Town Office at 403-783-4431 where Town staff can help fill out the online form for you.
