



## Residential Snow Removal Continues in Riverside

As Town of Ponoka crews continue working to remove snow from roadways throughout the community, snow removal operations are underway in Riverside (Zone 4) **today, February 2** along the following residential roadways:

- 42 Street Close, north of 40 Avenue;
- 41 Street Close north from 40 Avenue into the close;
- 40 Street Close, north of 40 Avenue;
- 39 Street, north and south of 40 Avenue;
- 39A Avenue Close, east of 42 Street;
- 42 Street from Highway 53 to 40 Avenue;
- 43 Street from Highway 53 to 40 Avenue;
- 44 Street from Highway 53 to 40 Avenue;
- 45 Street from Highway 53 to 40 Avenue; and
- 45A Street from Highway 53 to 40 Avenue.

Beginning tomorrow, **Tuesday, February 3**, snow removal operations will continue in Riverside along the following residential roadways:

- 46A Street Close, northwest of 46 Street;
- 38A Avenue Close, west of 46 Street;
- 45 Street between Highway 53 and 37 Avenue;
- 37 Avenue between 45 Street and 46 Street;
- 46 Street S from 46 Street and 35 Avenue; and
- 35 Avenue from 46 Street to 47 Street.

Snow removal on roadways in residential zones is expected to continue over the coming weeks. More details on which streets are scheduled to receive snow removal will be provided later this week.

Snow and ice control crews are also:

- Sanding roadways throughout the community as needed; and
- Sanding on sidewalks adjacent to Town-owned properties and on walking trails as needed.

### **'No Parking' Signs**

Please watch for 'No Parking' signs and move parked vehicles from roads when the signs are posted. Removing your vehicle from the roadway when 'No Parking' signs are posted in advance of snow removal operations is a requirement under the Town's Traffic Bylaw and can result in fines and towing of the vehicle at the owner's expense if needed.



Removing your vehicle from the road also helps crews conduct snow and ice control operations safely and more efficiently.

### **Community Advisory Signs**

Community advisory signs are also posted in residential neighbourhoods 48 hours in advance of snow removal operations to give residents notice of when snow removal is scheduled to occur.

Please note that changing weather conditions and new snowfall events can require crews to direct their attention back to priority routes and delay planned snow removal operations. As a result, crews may not complete the entire zone and will return at a later date.

### **How to Report an Icy or Snow-Covered Intersection, Roadway, Back Alley or Sidewalk**
