



Residential Snow Removal Underway in Riverside

As Town of Ponoka crews continue working to remove snow from roadways throughout the community, snow removal operations are underway in Riverside (Zone 4) **today, January 26** along the following residential roadways:

- 42A Street Close from 50 Avenue north to the end of the road;
- 42 Street from 50 Avenue into 42 Street Close;
- 38 Street from Highway 53 to 46 Street;
- 51 Avenue Close;
- 52 Avenue from 42 Street to 38 Street; and
- 39 Street from 52 Avenue to 42 Street.

Beginning tomorrow, **Tuesday, January 27**, snow removal operations will begin along the following residential roadways:

- 42 Street between 50 Avenue and 48 Avenue;
- 43 Street between 50 Avenue and 40 Avenue;
- 40 Street between 50 Avenue and 49 Avenue;
- 49 Avenue between 39 Street and west to the end of the road;
- 39 Street between 49 Avenue and 48A Avenue;
- 48A Avenue between 39 Street and 40 Street; and
- 40 Street between 48A Avenue and 48 Avenue.

Snow removal on roadways in residential zones is expected to continue over the coming weeks. More details on which streets are scheduled to receive snow removal will be provided later this week.

Snow and ice control crews are also:

- Sanding roadways throughout the community as needed; and
- Sanding and clearing snow on sidewalks adjacent to Town-owned properties and on walking trails, as well as clearing snow from park furniture (benches, picnic tables, etc.) in Town parks and throughout the trail system.

'No Parking' Signs

Please watch for 'No Parking' signs and move parked vehicles from roads when the signs are posted. Removing your vehicle from the roadway when 'No Parking' signs are posted in advance of snow removal operations is a requirement under the Town's Traffic Bylaw and can result in fines and towing of the vehicle at the owner's expense if needed.

Removing your vehicle from the road also helps crews conduct snow and ice control operations safely and more efficiently.

Community Advisory Signs

Community advisory signs are also posted in residential neighbourhoods 48 hours in advance of snow removal operations to give residents notice of when snow removal is scheduled to occur.

Please note that changing weather conditions and new snowfall events can require crews to direct their attention back to priority routes and delay planned snow removal operations. As a result, crews may not complete the entire zone and will return at a later date.

How to Report an Icy or Snow-Covered Intersection, Roadway, Back Alley or Sidewalk

To report an icy or snow-covered intersection, roadway, back alley, sidewalk or walking trail that may need attention, please submit an online service request by visiting the Town of Ponoka website at Ponoka.ca/p/online-service-request. Please note that the Alberta Ministry of Transportation and Economic Corridors is responsible for snow and ice control on Highways 2A and 53 in Ponoka. Please direct snow and ice control inquiries about these roadways to their contractor Main Roads at 1-877-875-3263.
