## 51 Avenue Redevelopment Project

Final Phase of the  
Project Has Begun



The following improvements are planned over the coming months for 51 Avenue (between 50 Street and 51 Street):

- Replacement of temporary asphalt sidewalks with new permanent sidewalks;
- Redevelopment and design improvements to the municipal parking lot on the south side of 51 Avenue;
- Final layer of asphalt paving on the roadway and line marking;
- Installation of pedestrian crossings;
- Landscaping including new shrubs and trees; and
- Installation of benches and garbage containers.

### Business Access Remains Open Along 51 Avenue

**Pedestrian access to businesses on 51 Avenue will be maintained throughout the project.** Ramps will be installed to business storefronts during the replacement of the sidewalks.

There will be a temporary interruption to storefront access for a few hours while concrete is poured for the new sidewalks at each storefront. However, alternate access options to these businesses will be facilitated at that time, allowing for continued customer access to 51 Avenue businesses throughout the construction period.

- **Got a Question or Service Request for the Town of Ponoka?** – Visit the Town website at [www.ponoka.ca](http://www.ponoka.ca), scroll down and click on 'File an Online Service Request' or you can phone the Town Office at 403-783-4431 where Town staff can help fill out the online form for you. You can submit online service requests for bylaw enforcement, park and roadway maintenance (including potholes) or any other service request or question you may have. By submitting an online service request, your question or concern is delivered directly to the appropriate department, which allows the matter to be addressed in the most timely manner. If you provide your email address, you will also receive notification when your request has been completed.
- **Street Sweeping Operations** – Town of Ponoka annual street sweeping operations are underway. Please watch for 'no parking' signs and move parked vehicles from roadways on which 'no parking' signage is posted. Moving parked vehicles from roadways allows crews to conduct street sweeping operations safely and more efficiently. Please note that vehicles only need to be removed from the roadway if 'no parking' signage is posted along that particular street. - **Green Carts and Recyclable Materials** bundled in clear or blue transparent plastic bags should be placed at the curb for pick up on May 24, 25 and 26 - depending on what Zone you live in.
- **Grey Carts and Green Carts** should be placed at the curb for pick up on May 31, June 1 and 2 – depending on your Zone.
- **Missed Pickups** – If your curbside recycling, compost (green cart) or waste (grey cart) was not picked up on your designated collection day, please contact E360S dispatch at 403-341-9300 or by email at [rddispatch@e360s.ca](mailto:rddispatch@e360s.ca).
