Did you know you can pay property taxes in 12 interest-free payments rather than one lump sum?

The Monthly Property Tax Payment Plan automatically withdraws your monthly payment from your bank account on the first business day of each month from January to December.

There are no additional fees or interest charges.

- Green Carts Switch to Winter Pick-Up Schedule Green Carts for compostable yard and kitchen waste will continue to be emptied weekly for the month of October. Starting November 1, 2022, curbside pick-up of Green Cart compost waste will happen every second week until April 30, 2023.
- Waste Transfer Station Switches to Winter Hours Starting November 1, the Waste Transfer Station will change to winter hours, which are Tuesday to Saturday from 8:30 a.m. to 4 p.m.
- Green Carts and Recyclable Materials bundled in clear or blue transparent plastic bags should be placed at the curb for pick up on October 26, 27 and 28 depending on what Zone you live in.
- Grey Carts and Green Carts should be placed at the curb for pick up on November 2, 3 and 4 – depending on your Zone.
- Missed Pickups If your curbside recycling, compost (green cart) or waste (grey cart) was not picked up on your designated collection day, please contact E360S dispatch at 403-341-9300 or by email at rddispatch@e360s.ca.
